General Language Use

In these General Use Terms, the words "we," "our," "Company", "Jindal Films" and "Jindal" are each used for convenience, and may refer to Jindal Films Americas LLC, Jindal Films Europe S.à r.l. or any companies affiliated with them in the production and sale of film products. There are a number of such affiliated companies, many with names including "Jindal" or "Films". Neither the use of these terms of convenience, nor anything else in these General Use Terms, is intended to suggest that those affiliated companies are not legally separate or that responsibility for local action and accountability does not remain with them. Abbreviated references describing global or regional operational organizations and global or regional business lines are also sometimes used for convenience and simplicity. They are not, generally, intended to describe precise legal status.

Your Agreement

Jindal Films and its affiliated companies ("Jindal" or "Company") provide this website ("Site") and certain services, documentation, interfaces, applications, tools, and other functionality on or via this Site (the "Services") to you subject to your agreement to comply with the following terms of use (the "General Use Terms").
